Back by Popular Demand, Suzanna Guzman to Sing at Christmas Gala

Catholic Charities' 2014 City of Angels Christmas Gala will be held on Friday, December 5 at The California Club in downtown Los Angeles. The Gala will honor the Archdiocese of Los Angeles Investees of the Equestrian Order of the Holy Sepulchre of Jerusalem, the Sovereign Military Hospitaller Order of St. John of Jerusalem of Rhodes and of Malta, and the Order of St. Gregory the Great.

Highlights of the evening will include a special vocal performance by Grammy-nominated East Los Angeles native Suzanna Guzman, accomplished mezzo-soprano and host of Open Call on KCET. Guzman, best known for her title role in Bizet's Carmen, has been honored by People magazine in Español as an outstanding Latino in Music, and was the first recipient of the Plácido Domingo Award.

Brownson House Center's Roberto Ramirez Presented Award by Los Angeles Food Bank

Roberto Ramirez, Client Resources Coordinator II of Catholic Charities' Brownson House Community Center in its San Gabriel Region, was recently awarded the Los Angeles Regional Food Bank's highest honor - the Tony Collier Award. Named after the founder of the Food Bank, this honor is given to a person who has exhibited extraordinary efforts to help ensure that no one in Los Angeles goes hungry.



Ramirez has worked at Brownson House Community Center, in the East Los Angeles community of Boyle Heights, for about 35 years. He does his best to provide what is needed by the people who come to the center, warming food for homeless persons when it's cold, stocking the food bags as heartily as possible, and always checking with parents to see if their children are interested in a special treat. He especially loves helping children, and they love seeing him. His sincere and humble care for them radiates from his every interaction, and they feel safe in his presence.

Ramirez knows that hunger in the Boyle Heights community is real, and he does whatever is within his power to allay it. In fact, if he is off work and receives a call about a potential food donation, he will stop whatever he is doing, rearrange his time, retrieve the donation, and bring it to Brownson House. He will not let such an

opportunity pass by, knowing that the food will immediately feed families, as well as nurture relationships that provide food in the future. If there is a large donation of fresh food, he will take it around the neighborhood, on his own time, to make sure it gets to hungry families before it perishes.

As one client gratefully wrote: "Roberto has been very helpful and always supported us with what we needed when he had it." The San Gabriel Region of Catholic Charities is very proud of Roberto for most deservedly earning the Los Angeles Regional Food Bank's highest award. ❖

Girl Scout Earns Gold Award for Guadalupe Center Project

Families who are clients of Catholic Charities' Guadalupe Community Center in Canoga Park joined to learn about healthy living at Ella Sudit's Gold Award project, Project Playtime. A Gold Award is a Girl Scouts' project that identifies a key issue in the community and helps to find a solution. The award granted as part of this 80 hour community service project is the highest honor a Girl Scout can receive.

In her project, Ella worked with the Guadalupe Center to teach families about healthy eating and exercising. First, Ella and volunteers met at the center, measured, marked tape, and painted hopscotch, foursquare, and tetherball courts. In addition, Ella donated sports equipment to the center, including balls, pumps, and nets.

Next, Ella hosted a "Fun Day" at the center for families. Throughout the day, various activities were organized to teach children about healthy living. A two-legged race was a perfect way to show youngsters how to work together and a balloon toss taught

them the importance of staying hydrated. Handball and Basketball games provided an opportunity to have fun and learn about team work. The children also colored worksheets that showed them the different fruits and vegetables to eat and various exercises and activities to complement nutrition.

In addition to the fun activities, Ella also donated a healthy dinner to the families of the center. This meal included fruits, vegetables, salad, and a hearty pasta dish. The youngsters also played with the new sports equipment. Finally, the volunteers served the families all-fruit popsicles.
