## Santa Maria Center **Helps Volunteer**

Tn Santa Barbara County, Elina\*, La young El Salvadorian woman, volunteers with the day to day operations of Catholic Charities' Santa Maria office. Elina left El Salvador five years ago hoping to legally work in the United States.

Recently, Elina learned that her 16 year old sister was a victim of rape and kidnap by a group of gang members, which caused her sister and her 20 vear old brother to flee the traumatic environment of their home town in El Salvador. Unfortunately, the situation took a more serious turn when they approached the Mexican border of the United Sates and encountered a gang which kidnapped Elina's siblings. The gang contacted Elina, demanding \$1,500 for release of her brother and sister to cross the border into the United States. Elina managed to give the money to the gang and her siblings were allowed to cross the border. However, after crossing the border, they were detained by U.S. Border Patrol. Elina's brother and sister are currently being held at separate immigration facilities in Texas.

Elina shared her story with Art Alvarez, Catholic Charities' Client Resources Coordinator in Santa Maria, who assists Elina by advocating for her siblings and helping her fill out necessary paperwork, including a 42 page document that had been sent by Texas Immigration authorities. We are hopeful that, through Art's diligence, we will be able to help Elina and her brother and sister reunite soon.


