PROVIDING HELP AND CREATING HOPE AMID THE CORONAVIRUS PANDEMIC

For 102 years, Catholic Charities of Los Angeles has provided social services to poor and vulnerable people within the Archdiocese of Los Angeles, Los Angeles, Ventura and Santa Barbara counties, helping clients to become self-sufficient. But, this past year has been an especially challenging one for the agency and for many others.

The 2020-2021 fiscal year began three months into California's already imposed statewide shutdown due to COVID-19. The pandemic caused widespread, devastating economic disruption, affecting the livelihoods of many people. In addition to the virus jeopardizing clients' financial health, negative consequences for their mental health were caused by the resulting anxiety, stress and social isolation.

The situation brought to mind words of Mother Teresa: "We think sometimes that poverty is only being hungry, naked and homeless. The poverty of being unwanted, unloved and uncared for is the greatest poverty."

Throughout the pandemic, Catholic Charities' staff, at our community centers, shelters and other programs, stepped up to the challenge with over 329,000 program services, plus over 173,000 additional services for the COVID-19 pandemic, to show our clients that they were cared for. Staff demonstrated kindness, empathy and emotional support as they Provided Help to the hungry and homeless.

As California reopened its economy and relaxed mask wearing and social distancing guidelines on June 15, 2021, there was "light at the end of the tunnel." But, employment levels of many of our clients are not predicted to return to normal soon.

Catholic Charities is grateful to you, our donors, volunteers and supporters, who joined in our mission in the past year, by sharing your time and financial resources to help us to Provide Help for our clients' increased material needs, as well as to Create Hope in our clients by showing them compassion and caring.

As Mother Teresa wisely said: "Not all of us can do great things, but we can do small things with great love." Catholic Charities does small things with great love.

When I think about the beautiful work of Catholic Charities here in Los Angeles, I see that "gaze transformed by charity," that Pope Francis speaks of.

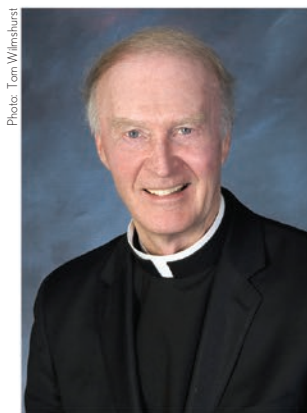

OUR LADY OF THE ANGELS PASTORAL REGION

The drive-through food pantry at St. Margaret's Center in Lennox provided up to 50 lbs. of food per week, for a total of 11,626 distributions to households over the pandemic year, as well as utility assistance for 1,026 families.

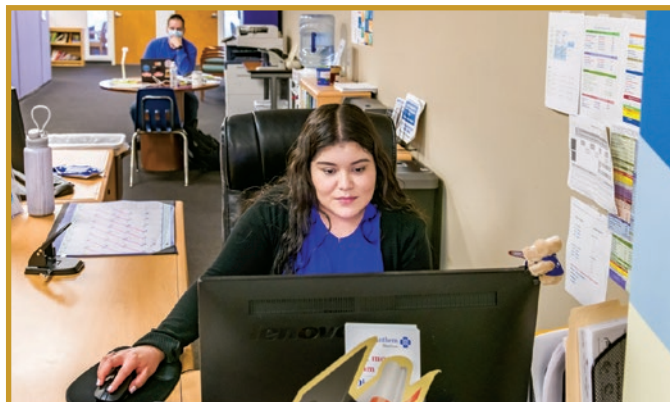

CATHOLIC YOUTH ORGANIZATION (CYO)



Due to the COVID-19 pandemic, Esports (video games) activities were offered throughout the year, with leagues and tournaments for 700 youth from 37 schools, grades 5-8. In person, St. Charles competed against Incarnation in Girls' Basketball.



CYO successfully restarted sports activities in the spring of 2021 with Boys' and Girls' Basketball, which tipped off in April. St. Rita opposed St. Philip the Apostle in Boys' Basketball.



CYO Boys' and Girls' Volleyball began in May and wrapped up in time for June graduations. St. Rita took on St. Bede in Girls' Volleyball.

MAJOR DONORS

Since 1919, Catholic Charities has served the needy and impoverished residents of Los Angeles, Ventura and Santa Barbara counties by providing emergency food and shelter, case management and supportive services. All programs help to enable clients to become more self-sufficient.

With the financial support of individual donors, churches, foundations, corporations, organizations and federal, state and local governments, as well as in collaboration with other social service agencies, Catholic Charities of Los Angeles rendered almost 800,000 services during the past fiscal year (July 1, 2020 through June 30, 2021). Without the help of these dedicated partners, the human services' work of Catholic Charities could not continue.
