McGill Street House, in the San Gabriel Region of Catholic Charities, provides seven-bed transitional housing for homeless women with children. It is a collaborative program with the City of Covina. The following was written by a former resident of McGill House:

My name is Yareli and I am now 17 years old. Recently, I was excitedly looking forward to purchasing a cute dress for the Homecoming School Dance with the \$75 that I had slowly set aside. However, something made me stop and reflect on whether a night of partying was worth that precious \$75. After thinking about it for a couple days, I came to the realization that it was not and that there was a better way to use my money.

I told my Mom that I wanted to use my savings to feed those who were hungry in downtown Los Angeles' Skid Row. She was so happy when she heard this that she even gave me more money so I could buy more food, including fruit.

The day that I was out on the streets with the homeless was an incredible experience. My happiness was overwhelming and

something unexplainable as I saw the smiles on the faces and savored the heartfelt expressions of "Thank you" and "God bless you!"

I learned to share with others, not because I had a lot to give but because I know what it means to, literally, have nothing. My family went through a really tough time when we had nothing at one point in our lives. My family is deeply grateful to the Catholic Charities' San Gabriel Region and the City of Covina. With our stay at the McGill Street Transitional Housing Program, we were able to lift ourselves out of the pit and we continue to work hard each day to stay where we are now. ❖


