The Project Achieve shelter in Long Beach was recently the recipient of San Pedro Region's "Guest Chefs" program. Scouts BSA Troop 25 of the Long Beach Area Council treated the residents to a dinner of spaghetti and meatballs, salad, bread and cookies, all prepared by the Scouts.

Ana Guillen, Data and Contract Specialist of Catholic Charities' San Pedro Region Programs, recalled, "it was one of the best experiences I had ever witnessed." The Scouts walked around the tables and talked to the residents. Each of the clients had a smile on his or her face and they all loved talking with the youth.

Project Achieve provides: 60-90 days of Bridge Housing and 24-hour shelter for

adult men and women; case management services; basic skills' workshops; and job and housing linkages.

The Elizabeth Ann Seton Residence in Long Beach has an innovative "Kids in the Kitchen" program hosted by Heather Blagaich, Chair of the program, and her fellow volunteers. They go to the shelter to help the mothers and children prepare food and cook together.

Ana Guillen shared, "it was great to see all the little ones and families cooking together and having a great time."

Elizabeth Ann Seton Residence offers: 45-days of Bridge Housing and 24-hour shelter services for homeless families, disabled and older adults; case management; and family life skills' classes. ❖

Message from the Executive Director, Rev. Monsignor Gregory A. Cox

On January 1, 2020, Catholic Charities officially ended our centennial year. We celebrated the past and we now anticipate the future. An American lawyer, William Jennings Bryan, once said, “Destiny is no matter of chance. It is a matter of choice. It is not a thing to be waited for, it is a thing to be achieved.”

Catholic Charities will continue to improve our existing services to the poor. According to the Los Angeles Homeless Services Authority, in 2019, approximately 60,000 persons were found homeless on any given night in Los Angeles County. Youth, from minors through age 24, make up 8,915 of the county’s homeless population. Catholic Charities provides critical services to assist the homeless with food, job training and housing,

We are also exploring ways to prevent homelessness by addressing its causes. For example, some youth who are aging out of the state’s foster care system just want to be done with it and voluntarily move out of their foster family placements, leading to many cases of homelessness. We have developed a model to house these youth before they fall over the cliff to homelessness.

Catholic Charities begins our second century by building on the past so we can creatively resolve the social issues of the future. We are grateful to our donors who assist us in bringing hope and dignity to those we serve. ❀

More than 100 refugee children, along with their families or sponsors, gathered at lunch tables in the Immaculate Conception Church parking lot on January 4, 2020, for the sixth annual “Fiesta De Los Reyes Magos” (“Three Kings Day”). The event, sponsored by Esperanza Immigrant Rights Project, a program of Catholic Charities of Los Angeles, celebrates refugee children and their sponsors and families alongside volunteers, donors, and staff. Honoring the “Reyes Magos” tradition of welcoming refugees, Esperanza staff and volunteers hosted play activities, broke a piñata, handed out gifts to children, raffled bicycles, offered delicious tacos and shared the traditional *Rosca de Reyes* (Three Kings’ Bread). “In the spirit of the holiday season and giving to those in challenging circumstances, Esperanza staff strive to make refugee minors’ first holiday season in the U.S. a memorable one,” stated Stephanie Lomeli of Esperanza. ❖



Christmas Arrives at the Community Centers

San Fernando Region helped 350 families through their Adopt-A-Family program. At Guadalupe Community Services Center in Canoga Park, all parents and live-in grandparents were given Walmart gift cards and all the children received toys. John Ford, a long-time Food Pantry volunteer at the center, served as Santa and food was provided at the party.

The Adopt-a-Family program in **San Gabriel Region** benefitted 45 families. The Navidad Con Obispo celebration distributed food baskets and toys to 144 families. Brownson House in East Los Angeles gave food baskets and toys to 126 families. San Juan Diego Community Center in El Monte provided food baskets and toys to 96 families. Pomona Community Center gave 100 families food and toy donations. McGill Street House hosted a party for nine families.

Long Beach Community Center, in **San Pedro Region**, gave 60 families food baskets and coats. Elizabeth Ann

Seton Residence was treated to two Christmas parties, one hosted by Our Lady of Refuge Catholic parish, which donated toys and coats to all the families. The second party featured Santa with lots of toys for the children.

The staff and volunteers of The Landing program at **Our Lady of the Angels Region's** St. Robert's Center in Venice cooked and served a Christmas feast of turkey, stuffing etc. at their Christmas party, which treated 19 adults and 16 children to a meal and toy giveaway.

The Ventura County area of the **Santa Barbara Region** distributed 404 food baskets and 100 gift cards to families, and

toys to 592 children. St. Jude Catholic parish in Westlake Village adopted 49 of those families. St. Peter Claver Catholic parish in Simi Valley adopted 40 of the families and 91 of the children at the Moorpark Service Center, where Santa was present. ❖
